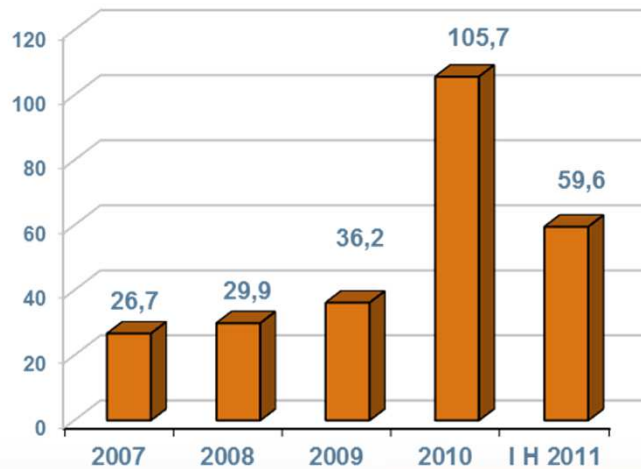

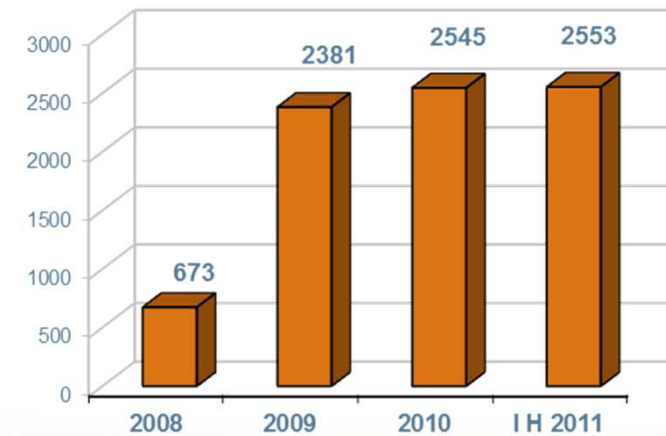

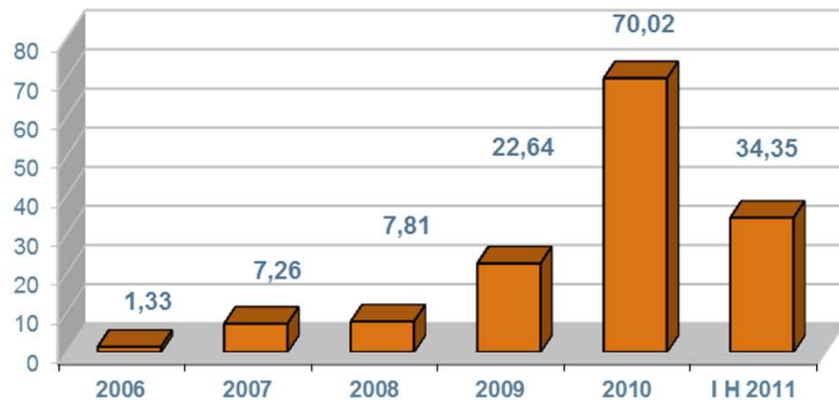

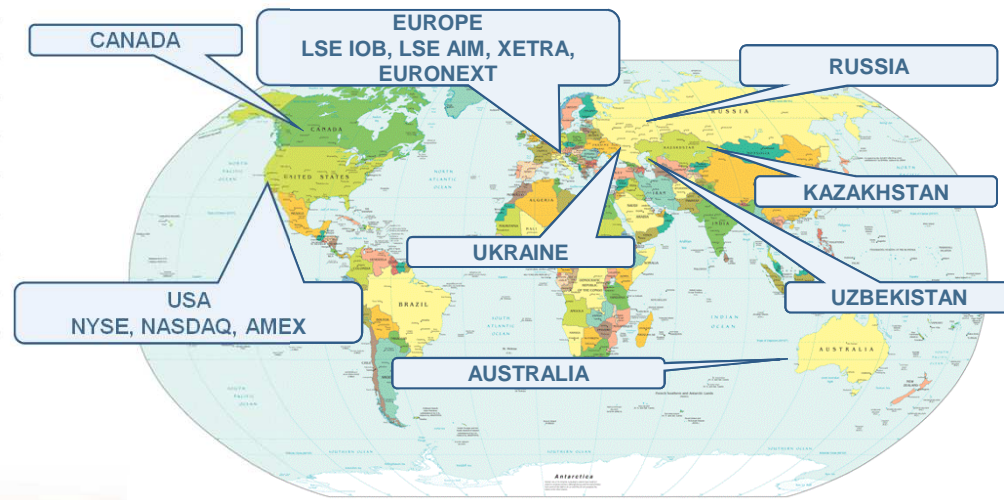

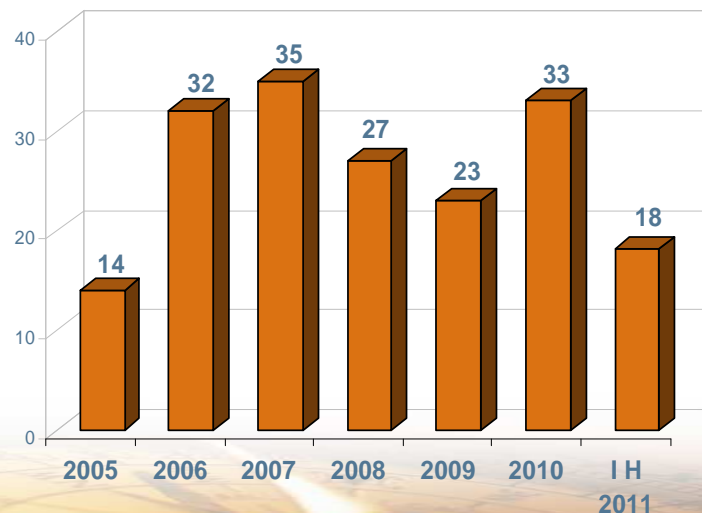

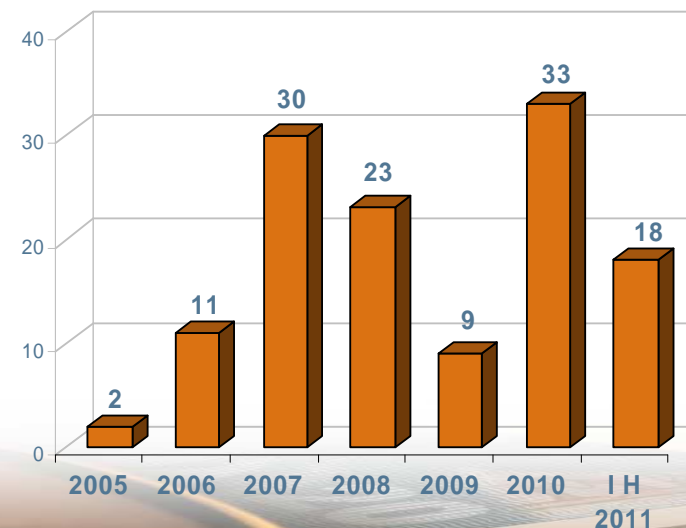

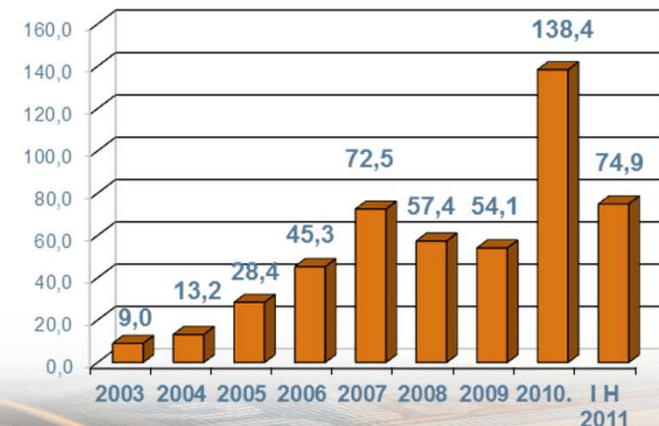

2007 - 1H 2011 bln EUR**












